#### NURS 2091 & 2092 Special Projects/Independent Studies

The course provides the study and/or analysis of selected topics in Nursing. It includes Individual and/or group study. This course may be repeated with a different topic up to 9 credit hours. NURS 2091/2 is designed to assist a student in strengthening his/her knowledge base in a specific nursing topic. This can be accomplished through independent assignments in nursing literature, films, computer-assisted instruction, web-based research, reading, and/or mentoring.

<u>Course Purpose</u>: The purpose of this course is to supplement learning strategies for

nursing content.
